

BID NOTICE

The Gillespie County Water Control and Improvement District No. 1, Fredericksburg, Texas is requesting sealed bids from qualified, responsible bidders to construct the rehabilitation of Williams Creek Watershed Site 3 Floodwater Retarding Structure. Site 3 is located in the southeast corner of Gillespie County, approximately 2.7 miles southwest of Albert, Gillespie County, Texas.

Estimated Price Range: Between \$1 million and \$5 million

The major items of work are (quantities are approximate):
