

BID NOTICE

The Gillespie County Water Control and Improvement District No. 1 (GCWCID-1), Fredericksburg, Texas is requesting sealed bids from qualified, responsible bidders to construct the UPGRADE of Williams Creek Watershed Site 1 Floodwater Retarding Structure located about 1.2 miles south of Albert, Gillespie County, Texas.

Estimated Price Range: Between \$5 and \$10 million
